Terms of Membership

- I. Membership at SpVg Laatzen von 1894 e.V. is mandatory!
- II. This additional declaration of membership for the tennis department has to be filled out completely, even if you are already a member in any other department of the SpVg Laatzen von 1894 e.V.
- III. Membership fees of other departments do not affect the fees for the tennis department and have to be paid additionally.

Conditions of Use

- IV. The tennis courts may only be used if all the conditions above are met.

Admission fee

There is no admission fee for the tennis department in effect.

Annual Membership Fees for the Tennis Department

Annual membership fees for the tennis department are listed per person and do not include compulsory membership fees of the main club of SpVg Laatzen. *First time members are eligible for a 50% discount on their first-year membership.

**Children under the age of 18, or adults with proof of primary education (School/Apprenticeship/University) under the age of 28.

Work Service and additional costs

Annual work service for tennis members are 5 Hours. If you are not able to fulfill the work service in the given period of time, you are subject to a € 62.00 fine per person per period. Adolescents beginning at the age of 15 have to fulfill 3 Hours of work service per year. If you are not able to fulfill the work service in the given period of time, you are subject to a € 23.00 fine per person per period. You have to provide proof of the fulfillment of the hours!

The annual fee does not include costs for guided workouts!

Price for keys to the tennis campus (per key/once): € 5.00

Security deposit for keys (will be refunded after return): € 10.00

For new members the first payment is to be paid by bank transfer to the bank details below. The following transactions will be debited off your account. Payment must be made by January 31, of each year (see note (1) and (2) of the payment conditions).
